THANK YOU FOR HELPING US SHAPE THE FUTURE OF AUCKLAND'S CENTRAL WHARVES

Auckland Council is developing a Central Wharves Masterplan. The goal is to improve public access and activity on the waterfront and strengthen the connection between the city centre and Te Waitematā Harbour.

The starting point for this work was to test the ideas specific to the central wharves in Port Precinct Framework Plan. This was an indicative plan that considered options for the future of the port precinct.


This document provides a **summary** of feedback from this early public engagement.

The next step will be to use feedback from the public, our partners and stakeholders, alongside technical input, to develop a **draft masterplan for testing and consultation.**



THE FRAMEWORK PLAN SUMMARISED

ENGAGEMENT PROCESS

People could provide feedback from Saturday 12 April to Sunday 11 May 2025


The engagement process centred around a series of activations on Queens Wharf, called Downtown Days, to draw people to the site and start imagining the future of the central wharves. Downtown Days comprised:

- Four family friendly activation days on Queens Wharf. A fifth day (Thursday 17 April) was planned but had to be cancelled due to poor weather
- A stellar line-up of musicians, DJs and theatre
- Walking tours around Queens Wharf with 'time travellers from the future' to help people imagine potential future scenarios
- Kids craft activities
- An interactive sound recording booth 'the EggFruit' where people could record their aspirations for the future


Information was provided on the AK Have Your Say and Eke Panuku websites. The AK Have Your Say page included a feedback form and ability to drop comment pins on an interactive map

This was all supported by a communications and social media campaign to raise awareness and attract interest















FEEDBACK CHANNELS

People could provide feedback in a number of


- Online via the feedback form and

PUBLICLY ACCESSIBLE SPACES / SEATING & VIEWING -44%

Almost half (44%) of people mentioned a desire to open up the wharves for more public access, this included wanting:

- + Public spaces in the area (especially green space)
- + Places for people to sit, watch the boats and water, and hang out / gather together
- + Vibrancy, energy, and people on the wharves
- + Open and unstructured spaces (especially with art)
- + Connection between the wharves and the wider city centre to create a pedestrian friendly downtown

"the focus of the development should be on how the public can use the space"

"allow people to enjoy the view of the harbour..... areas for people to congregate"

TREES, PLANTING, GREEN SPACE - 41%

The second most frequently mentioned theme was a desire for more greenery, planting, trees and parks:

- + The wharves are currently seen by some as 'barren expanses of concrete'
- + Support for green areas and parks for families and others to enjoy e.g. for picnics
- + Support for trees and other planting, especially native plants to make the wharves more attractive and provide shade

"all of the wharves should become tree-lined, even if they have to be in big pots"

"I would come down more often if there was more green space, real grass, big trees, and, like, a park like environment"

FAMILY ACTIVITIES / PLAYGROUNDS - 39%

Over a third (39%) wanted to see family and childfriendly places, facilities and activities:

- mentioned
- something to do

"we would love to bring our kids downtown to spend the day in the city, watching the boats come & go, picnicking"

"a fun, interactive space for families"

+ Playgrounds, play facilities and play areas were often

+ Support for areas that attracted families and gave kids

+ This included a mix of indoor and outdoor spaces, and play activities for a range of ages



KEY THEMES







FOOD & BEVERAGE, CAFES, BARS, RESTAURANTS -30%

Another popular theme was a desire for food outlets, cafes and bars:

- + Cafes and restaurants were frequently mentioned
- + Support for bars and an entertainment area
- + Some talked about smaller food truck type offerings and coffee carts

"ensure that there are a myriad of restaurants, cafes... to ensure that both visitors and residents can enjoy this previously inaccessible waterfront asset"

"so it could be something, kind of like Nyhavn in Copenhagen with lots of cafes and restaurants and places to sit and some colorful buildings"

SPORTS ACTIVITIES (COURTS, SKATING) - 26%

A quarter of people mentioned a desire for a range of sporting facilities:

- + This included courts such as netball, basketball, football, tennis and pickleball
- + Skating areas and facilities were also mentioned
- + This theme was especially strong in relation to Hobson Wharf

"netball court for a netball league in the city centre"

"please turn it into a skate park. Even if it is not fully enclosed, having it partially enclosed with lights would be amazina!!"

"a sports facility here [Hobson] would have to be highly visible and cater to a sport with a dedicated community. I think a covered football or futsal facility or skatepark would be a good fit for the location"

A quarter also mentioned wanting opportunities to engage with the harbour in some way:

- closer to the water's edge

"this wharf is often used by fishermen, integrating that into the development would benefit the current use"

ENGAGE WITH THE WATER (FISHING / SWIMMING) -

+ Fishing off the wharves was often mentioned - and a desire for this to continue and be supported

EVENTS & PERFORMANCE (THEATRE, AMPHITHEATRE, MOVIES) - 24%

Some people talked about having areas and spaces to host events and performances, including:

- + Flexible spaces that could host performances, theatre and/or movies
- + An outdoor or water-based amphitheatre
- + Some felt that if the Cloud was to be removed, we would need an alternative event space on the wharves to take its place

"music, conferences, other events that are currently housed in the Cloud and Shed 10"

"a public space for exhibitions, performances, trade shows would be perfect"

"floating music amphitheatre on the water like overseas"

ART, SCULPTURE & CRAFT - 22%

Some also talked about incorporating public art and sculptures into the design for the wharves, and/or places to get involved in making art and craft:

+ This included a mix of permanent and temporary or rotating exhibitions, along with art and sculpture walks

"rotating public art or events would keep the energy fresh all year"

"definitely one of [the wharves] should be an arts precinct, potentially the one with Shed 11 on it"

"I'd come down to the wharf if there if there were more family friendly things to do like outside art, outside art activities to do"









KEY THEMES PER WHARF

- + Don't spend the money / leave the area as is / other priorities for council






